Safety Policy

- Work parties are organized to carry out general routine basic maintenance at SPS waters.
- SPS members are invited to attend to carry out general maintenance which requires no specialised training for tools or other equipment.
- A first aider will be in attendance at all work parties.
- A basic first aid kit will be provided and kept with the first aider.
- A risk assessment will be circulated to all attendees prior to the event.
- A safety briefing will be carried out by the event leader prior to any work starting.
- A register of attendees must be compiled.
- Any accidents will be recorded and reported to the Main Committee

If you notice darkening clouds, volatile and rough changing winds or sudden drops in temperature, play it safe by getting off the water. • Use Common Sense - One of the most important parts of boating safety is to use your common sense. • Be aware of other anglers on the lake. Leave space between you and the bank and other punt users. • Let someone know your fishing/boating plan. Let them know what time you expect to return • Avoid Alcohol • Learn to Swim if you can't already • Inspect punt prior to use and report any defects. This risk assessment should be reviewed & amended accordingly for example:

- If to be used in respect of work on a larger river or lake (particularly if a boat is to be utilized as part of the working activity) and/or proximity to deep water will be experienced e.g. need for life jackets and rope & harness.
- if you think it might no longer be valid (eg following an accident or if there are any significant changes to hazards, such as new work equipment or work activities e.g. use of electrical equipment, or use of cement or other chemicals (COSHH) or bonfires)
- If blue-green algae or pollution is present in worksite postpone the task.
